Lynn McKelvey, (Walter Presley) 5105 Teakwood Trace, Midland, TX 79707 March 5, 2007, I just got the Company I Poopsheet and read about Carentan. Do you remember me telling you about the book my cousin wrote of my Dad's (Walter Presley) memories? Anyway, there is a little bit in the book about Carentan. I can't tell if he participated in the bayonet charge because that was where he got his first purple heart. It appears he was wounded during the strafing. He and a buddy were fitting themselves into a hole big enough for only one person during the strafing. Dad was injured on the side next to his buddy (he says they were so close you couldn't have gotten a toothpick between them) and yet his buddy wasn't injured! Weird, huh? As he was helping to carry the more severely wounded back, he asked for

some sulfa powder and the medic hauled him to the hospital. After laying on his stretcher for the rest of the night and the next day without getting treated he hitched a ride with a truck driver back to his outfit. He says, "So I piled in that truck and went with him because, hell, they were not doing anything for me there. Just letting me lay on that stretcher. I guess they was too busy with more seriously wounded soldiers. So I went back up and went to our own medic. He put sulfa powder and bandaged it up. The thing healed. It didn't get infected. I got a Purple Heart for that." It doesn't sound like he was in the bayonet charge, but I thought I'd let you know what he said... I'll be sending you \$\$\$ for the Poopsheet. I am so grateful you are keeping it going. Thanks. -- Lynn

Caarentan Historical Center Robert G. Cole Memorial

March 4, 2007, Michel deTrez, Director, informed us that Pvt. Edward Sowder, Item Company, 502 was the chosen 3rd trooper image accompanying Cole on the bonze monument they plan to erect near Bridge # 4 and the causeway into Carentan at the Cole Museum facility.

The planned monument (Photo on another page) will stand in memory of LTC Cole and men of the 3rd battalion, 502 PIR in the liberation of the town of Carentan on June 11, 1944. LTC Cole was awarded the Medal of Honor for this action. The monument is made up of four images:

Cole leading the charge and charging at Cole's right stands 1SGT Kenneth Ned Sprecher. Ken Sprecher, 1st Sgt of "H" Co., 3rd Bn. was awarded the Distinguished Service Cross for extraordinary heroism during the charge.

Charging at Cole's left stands PVT Allen Emery, a mortar man from "HQ" Company, 3rd Bn. 502nd PIR, awarded the Bronze Star for exemplary conduct in combat at Carentan.

Prone on the ground, passing his bayoneted rifle to LTC Cole, is Pvt. Edward Sowder, Item Company a paratrooper from "I" Company, 3rd Bn., 502nd PIR. Sowder was a member of the premier 502nd Regiment in 1941-42. Ed was age 25 when he was wounded and died soon after from the head wound

incurred just prior to the bayonet charge at Carentan on June 11, 1944. The monument faces, as well as uniforms and equipment, will be sculpted from photographic records, and are not completed in the photos.

Walter A. Murdock of Placerville died March 6, 2007 at the age of 87. Walter was born and raised in San Francisco. He served with the 101st Airborne Division in World War II as a paratrooper, earning a Bronze Star and a Purple Heart - one of the "Greatest Generation". He married Irene Blalock during the war and after the war they moved to the Bay Area and had one child, Mark. Walter worked for PG&E until he retired and moved to Diamond Springs where

Irene passed away. Walter is survived by his wife, Kay, son, Mark (Linda); granddson Shane (Traci); great-granddaughter, Haylee; and Kay's daughters, Susan Adam and Cheryl Johnson and granddaughter, Shawn Johnson.; brother, Hugh Murdock; and sister, Bertha Morris.

Walter was a Masonic member for over 50 years. He was a member of the Shriners, Scottish Rite, Odd Fellows, Order of the Eastern Star (was Worthy Patron four times), Native Sons of the Golden West, SIRs, VFW, and the American Legion. Dear Mr. Sowder

Reference is made to your letter requesting additional information regarding the death of your brother.

Your desire for complete details regarding the death of your brother, Private Edward R. Sowder, Army Serial number 119940, Parachute Infantry, is most understandable. Additional information has now been received which confirms the previous report of death and shows that he received a gunshot wound of the head in action 11 June 1944 in the vicinity of Carentan, Normandy, France, during an attack against the enemy. He was immediately evacuated to a hospital where he received the very best medical care available, but death occurred the same day as a result of those wounds. I regret that no further details were given.

Permit me to extend my sincere sympathy in your great loss.

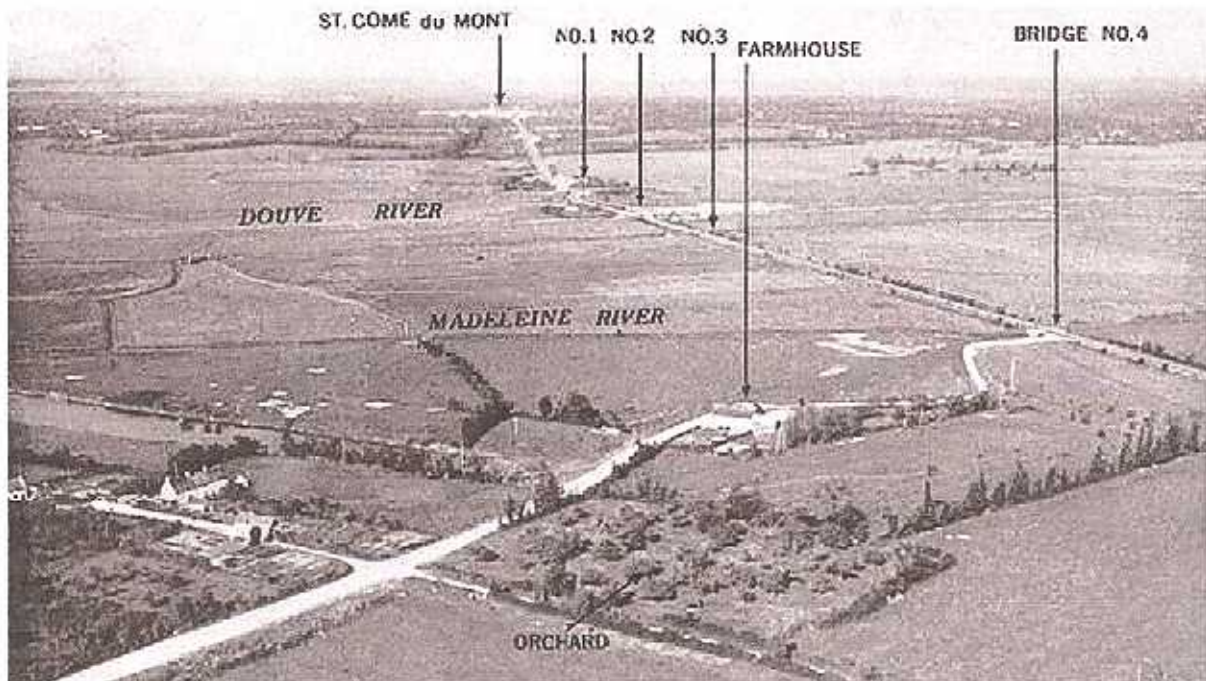
COLE'S BAYONNET CHARGE NATIONAL MONUMENT

a project of the Carentan Historical Center



For gallantry and intrepidity at the risk of his own life,
above and beyond the call of duty

United States of America Paratrooper Memorial CARENTAN
Normandy France 11 June 1944



The battle for Carentan was one the bloodiest of the U.S. Airborne's history. After five days of fierce combat at the edge of Carentan, Lt. Col. Robert Cole, while pinned down by intense enemy fire, searching desperately for an ultimate way to sealed the fate of the opposing German paratroops and break into Carentan, lead a desperate bayonet charge upon the enemy.

The battlefield at Carentan has changed very little since 1944. Today, there stands nothing to recall one of the most decisive battles ever waged by U.S. paratroopers on French soil and the terrible losses suffered there. Cole's Bayonet Charge National Monument commemorating the sacrifices made during this decisive victory will stand as a symbol of a grateful region's esteem for the honored dead of the U.S. Airborne.

The site selected to erect the monument is the same pastoral beauty that was witness to such violence and heroism on that day of June 11, 1944.

The plan calls for the giant 3,5 tonnes bronze four character statue to be standing in the heart of the battefield near Bridge # 4 (Silver Star Bridge), at the end of Purple Heart Lane. This is on the very land where the famous bayonet charge took place. It is also on the hearth of the Natural Park Des Marais, at the city limit of Carentan, overlooking the Ingouf farmhouse where the German paratroops set up their defensive line. The monument commemorating this pivotal battle will vanguard the entrance of the new Carentan Historical Center devoted to honor and recall the event of June 1944.

Commmemorating the distinguished service of the men who have served their nation for our freedom, the statue captures a glimpse of the most significant moment of the bayonet charge extracted from Cole's Medal of Honor citation - With utter disregard for his own safety and completely ignoring the enemy fire, LTC Cole rose to his feet in front of his battalion and with drawn pistol shouted to his men to follow him in the assault. Catching up a fallen man's rifle and bayonet, he charged on and led the remnants of his battalion across the bullet-swept open ground and into the enemy position.

On the imposing stone pedestal fiercely displaying the Screaming Eagle of the 101st Airborne Division, one will be able to read on bronze plaques the official citations awarded to these valorous paratroopers. These four men selected to represent the instant of history commemorated in the monument will forever stand as the stunning symbol of bravery and heroism of the United States Army Paratroopers.

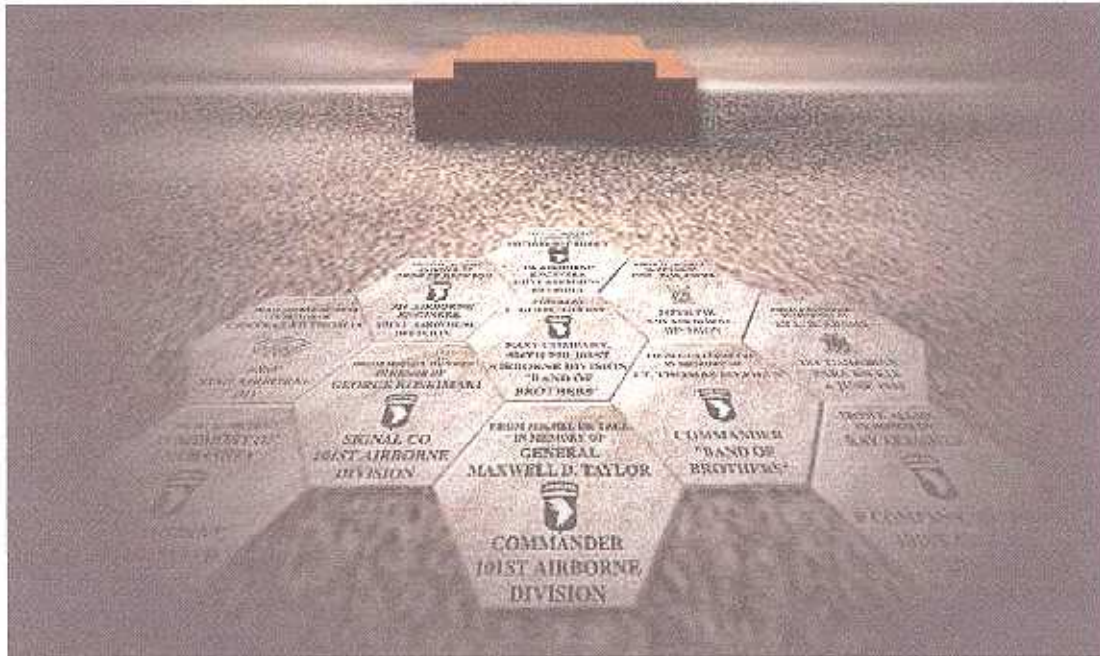

As you walk on the museum grounds, you will notice a path made of engraved stones. Each stone is beautifully engraved with a WWII airborne veteran's name and unit. Created to pay tribute to those airborne veterans who fought in the ETO during WWII, these stones make the Carentan Historical Center a unique place of remembrance. The Airborne Path lies on the historical field where Cole started his famous bayonet charge, where the blood of so many was spilled. The names of these brave men will remain on this significant battlefield site for generations to come, for all to see and recall. Years from now, when WWII is but a dim memory relegated to history books, most visitors will wonder who these men were. They were Airborne, and who they were, and what they did, is what these future generations will learn inside the museum.

BECOME A PART OF THE AIRBORNE MEMORIAL PATH

If you fought in Europe during WWII with an airborne unit (or were attached to an airborne unit), if you flew paratroopers into combat as part of the Troop Carrier Command or if you participated in the liberation of Carentan, then you are eligible to take your place here, among these heroes. Leave a mark by having your name and unit engraved on one of these stones and placing it on the Airborne Path.
